An ingenious recovery solution for Microsoft® SharePoint®, Recovery Manager for SharePoint empowers the IT administrator, to perform a complete SharePoint farm restore and item-level granular recovery. While - individual documents, lists, document libraries, sites, workspaces, IT administrator are recoverable, it is possible to locate, deleted, or modified the SharePoint documents and other items, and restore them from a content database backup.

It provides solutions for two scenarios:

## Disaster Recovery

It is a larger recovery plan, which is sensitive to various environment variables. Whether it is one critical component or the entire SharePoint server farm, A Disaster Recovery Manager restores all the data when lost. Administrators need careful planning of the process, prior to a potential disaster, there should not be any: Missing accounts, misspelled server names, or lack of necessary security logins on a SQL server.

## Content Recovery

A user-driven operation, Content Recovery Manager accidentally deleted or overwritten data, restore deleted documents, lists, and document libraries from the Recycle Bin, deleted by them from that particular site. It even allows creating versions of lists, documents, libraries, so it can roll back changes made by mistake and recover from document overwrites.



## Restore Scenario

Restore scenario with Recovery Manager includes a suit of actions that result in:

### No New Backups

There is no need of a new back-up system, SharePoint users can use the existing backup infrastructure to schedule native backups.

### Fast Find

A normal recovery routine involves searching files in recycle bins and generate backups natively. Cutting down this long process, recovery Manager enables a quick search across the multiple backups, making content discoverable through keyword, file type, and date.

### Complete Restores

Complete data restore is conducted through this software, which includes everything from all permissions, metadata, and version history.

### Access Anytime

Recovery of content to desktop or file share is possible even while SharePoint is offline. SharePoint user have emergency access to the entire SharePoint content all the time, so that it is possible to retrieve a business-critical data even before the entire server farm restoration is conducted.

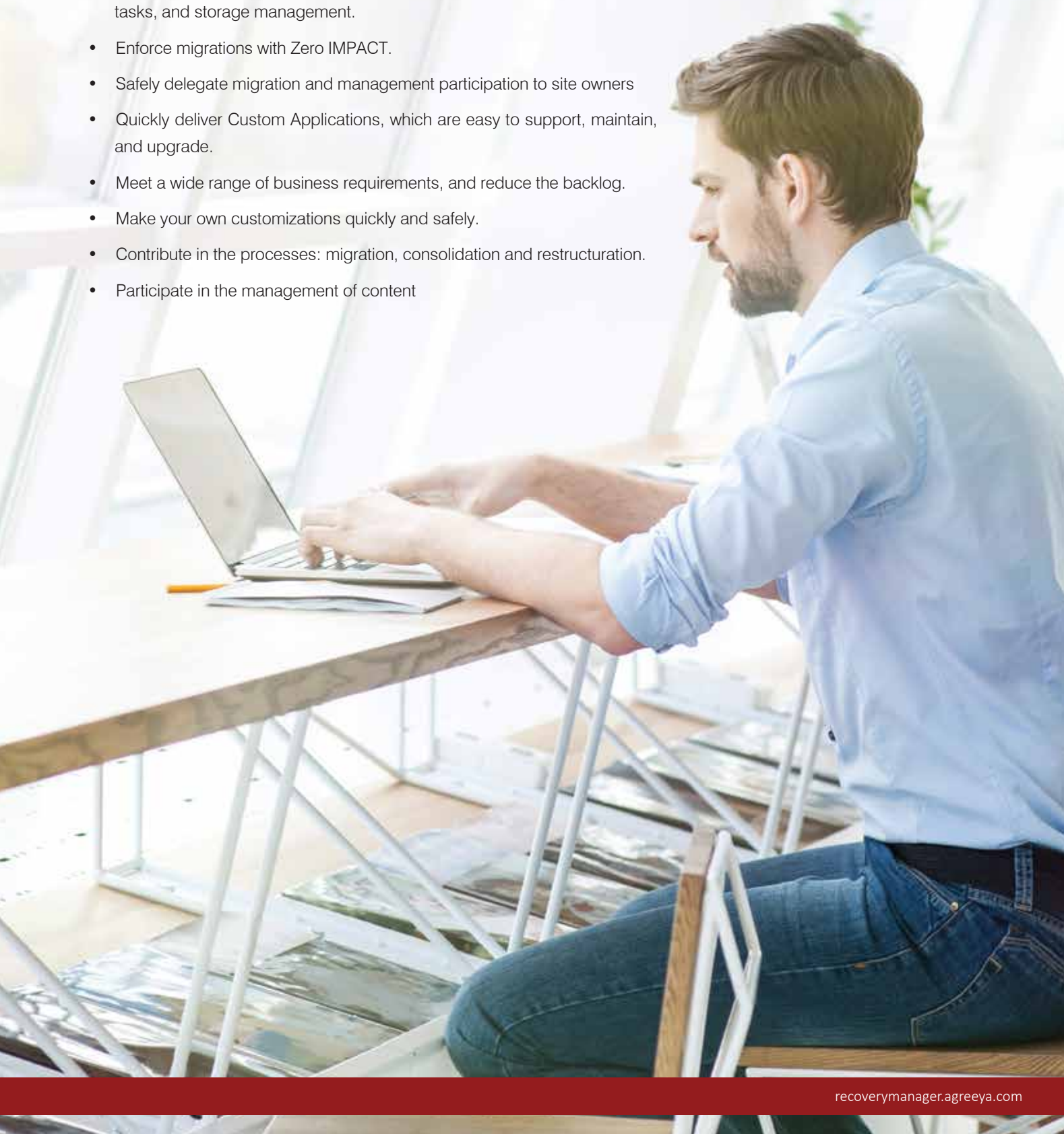
### Recover All
